

# **Profiles of ASARECA New Board of Directors**

# 1. Dr. Hussein Abubakr: Chairman Board of Directors



Dr. Hussein Abubakr was elected the first Chairman of the reconstituted ASARECA Board of Directors during its first meeting on May 3<sup>rd</sup>, 2019 in Kampala, Uganda. He is one of the five representatives of the National Agricultural Research Institutes (NARIs).

He holds a PhD in Business and Development Economics and is currently working as the Director General of (Agriculture Research Council) ARC, Sudan. Dr Hussein has more than 20 years experience in the formulation, implementation and management of strategies, programmes, policies and projects in research,

business and agricultural development. He worked as Director of the Institute for Development Studies and Research, University of Khartoum for 5 years. In addition, he has proven leadership and membership to teams for design and evaluation of development programs with various organizations including the United Nations Development Program, the World Bank, FAO, IFAD, Arab Organization for Agricultural Development, Arab Organization for Agricultural Investment and Development and the African Union, among others.
